We apologise for the delay in responding to your aforementioned letter. The letter only came to our attention on 10 October 2022.

Please be advised that our records reflects the following:

1. Mr Daniel Lungisani Mantsha was initially admitted as an attorney on 11 November 1997.
2. He was subsequently suspended from practicing as an attorney on 12 March 2004 pending an application to have him removed from the roll of attorneys.
3. He was eventually removed from the roll of Attorneys on 25 July 2007. A copy of the Court Order pertaining to his removal is attached hereto marked as annexure A.
4. Mr Daniel Lungisani Mantsha applied for his re-admission and was as a result, re-admitted on the Roll of Attorneys on 08 December 2011. For ease of reference, please find attached hereto a copy of the Court order marked Annexure B

Please note further that we have also commenced with an Investigation into the allegations of corruption and misconduct against Mr D L Mantsha as recommended by Justice Zondo in the Judicial Commission of Inquiry into State Capture report.
